### **Update on Europeana Network Association**

#### **Overall update**

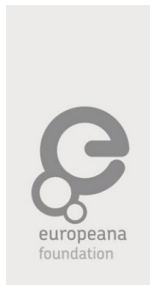
Since the last update, the major focus of the Network Association has been on setting up of [six Network communities](#). We have been working on establishing the rules and functional terms of reference for the communities, and accommodating work of the Network Association [Task Forces](#) and [Working Groups](#) within those. Further activities revolved around the 2018 Members Council elections campaign, and planning and execution of the AGM and the third Members Council meeting of the year.

#### **Membership**

The current Association membership stands at [2065](#) (number updated 26/10/2018).

#### **Network Engagement**

There are currently six active Europeana Network [communities](#): [Europeana Tech](#), [Europeana Impact](#), [Europeana Copyright](#), [Europeana Research](#), [Europeana Education](#), and [Europeana Communicators](#) group. These communities will be invited to present their work progress at the next Members Council meeting in December 2018. The Secretariat together with the ENA Management Board has established the rules and functional terms of reference for the



communities. They will be reviewed and formally approved by the Members Council in December 2018.

[6 Working Groups](#) are currently running and are involved in ongoing activities: [Library](#), [#AllezCulture](#), [Data Quality](#), [Copyright](#), [2018 Governance WG](#), and [2018 AGM WG](#).

[4 Task Forces](#) are currently running: [Europeana Resource Citation and Object Identity Standardization](#), [Creation and Governance of EDM mappings, profiles and extensions](#), [Europeana Migration](#) and [Impact Assessment no.2](#). The approval process of the Task force proposals and overall terms of reference have been undergoing revision in light of having the new communities in place, and will be formally approved by the Members Council in December 2018.

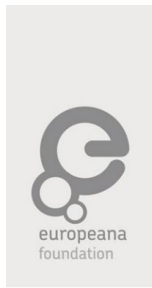
Since the last update, two Management Board calls took place (September, October). The next meeting will take place on 5 November.

### **Members Council elections 2018**

We have started the [2018 Members Council elections campaign](#), inviting the Network members to come forward or step up again to fill at least 28 open seats by submitting their candidacy [online](#) before 13 November 2018. The campaign will last until the start of the elections on 5 December.

### **Members Council meeting - December 2018, Vienna**

The preparations of the Members Council meeting on 4 December in Vienna have started. The agenda has been drafted and is currently undergoing review of the ENA Management Board. The meeting will address the work progress of the communities, Task Forces and Working Groups, and review of their terms of reference. The Council will be asked to discuss the Members Council elections 2018 and the Association budget, and to formally approve the Association's Annual Report 2018 and Activity Plan 2019. The Councillors will also be asked to reflect on their 2-year term and come up with suggestions for improvement as a part of their



legacy for the newly elected Council.

## **AGM 2018**

We are in the final stage of organizing the [AGM 2018](#) on 5 December at the Technisches Museum Wien in Vienna, Austria. The [programme](#), which will be focusing on the six communities and celebration of the 10th anniversary of Europeana, has been finalized and will be published shortly. So far, 165 People have registered for the event.
